#### **Objective of the Courses**

#### **Faculty members**

In a world where precise measurement is the cornerstone of fair trade and consumer protection, legal metrology plays a pivotal role in ensuring the accuracy and integrity of measurement systems

To make harmonization in Legal Metrology worldwide, The Indian Institute of Legal Metrology, Ranchi, India gives its contribution by imparting the training in its field. It is known that training and development of human resources has evoked a great deal of interest in recent years. Training is a systematic process of changing the behavior, knowledge, and attitudes of present employees to improve the match between employee characteristics and employment requirements. Training and development function in an organization has gradually become a major activity since the continued effectiveness and efficiency of an organization depends on the ability of its employees to produce at high levels of efficiency, and keep abreast with their changing job-role demands.

The objective of training is to develop specific and useful knowledge, skills and techniques and to make them familiar with the Legal Metrology system, International traceability, testing procedure of weight, measure, weighing Instrument and Measuring instruments as per the International best practices in the field of Legal Metrology. The objective of the training is to spread the knowledge about the Metrological control of the Legal Metrology in weight or Measure as well as in packaged commodities.

#### Methodology of the Training

Institute adopts broadly three methodologies to impart the training-

- > By conducting theory classes to enrich the participants about the Legal and Technical aspects of the Legal Metrology. Under theory classes, Lectures, study notes, worksheets, group discussion etc. is covered.
- > By conducting Practical Classes to make them familiar with practical approach in technical aspects of the Legal Metrology. Under practical classes, participants have to performed the experiments and have got the opportunity to learn the verification/testing process of the weights, Measures, weighing Instruments and Measuring Instruments.
- > By conducting field visit to make the live demonstration of the verification/Testing procedure of the weighing and measuring Instruments.

Evaluation of Training - At the end of the training, a general questioner will be provided to evaluate the training outcomes.

Awarding of Certificates - All the participants will be awarded with Certificate at the end of the course.

Duration of the training Program: One week/Two week

**Eligibility criteria for the training:** Nominated Foreign Officers of the Legal Metrology departments through proper channel based on Rules/regulations of concerned Ministries/Department of India and source countries.

Number of the Participant: - In one course, Number of participants may not exceed 25.

Course fee: - Course for one week programs- Rs. 21,000/ participants (in Indian currency) and for

Two-week program- Rs. 42,000/participant (in Indian currency)

Accommodation Charge: Rs 800/day for single occupancy in Hostel room

Food Charges: - Rs 700/day which will include Breakfast, Lunch, Dinner and two time high tea.
