Grading system is as follows:-

Overall grading on the basis of final percentage of Marks (M) scored out of total marks in final examination has been awarded as per following grading system:-

If	$90\% \leq M$	then final grade shall be 'A'
If	$75\% \leq M < 90\%$	then final grade shall be 'B'
If	$60\% \leq M < 75\%$	then final grade shall be 'C'
If	$45\% \leq M < 60\%$	then final grade shall be 'D'
If	$33\% \leq M < 45\%$	then final grade shall be 'E'
If	$M < 33\%$	then final grade shall be 'F'

**Explanation-1** In consequent to advisory issued on 27.12.2019, the result of the candidate may be declared as successful who attains overall minimum 75% attendance in theory and practical classes along with the awarded grading.

**Explanation-2** However if the candidate(s) awarded **overall grading "F"**, the Institute will inform to the respective Central Govt./ State Govt./UTs about the performance of the candidate in the training and further if respective Government think fit, may depute the candidate(s) in four months basic training course as a fresh to improve their skill as well as to upgrade the grading within two years from the date of publication of final result of their respective session.

**Explanation-3** The candidate who has attended the theory and practical classes during the entire training course with overall minimum of 75% attendance, and could not appear in field visit program and in the Paper(s) of the final examination, may reappear in any subsequent session of the Basic Training Course to complete the left over activities including paper/papers of final examination within two years from the date of publication of final result of the respective session to award the grading.
